OWINN

The Nevada Office of Workforce Innovation (OWINN) under the administrative umbrella of DETR administers NPWR and its grant program.


Grantees will submit monthly reimbursement requests with the official form and include any applicable backup documentation. Reimbursement requests must be submitted by the 15th of the following month (ie January's expenses must be submitted by Feb. 15th)

Projects can have a maximum total amount of \$50,000 for a project with multiple researchers and/or students; up to \$4,000 for an individual professional with no students; up to \$3,000 for an individual student at the Master/PhD level.

The last month of reimbursement (June 2026) must be submitted by July 15th and must include the final report of the research.

All grantees and other vendors must register as a vendor with State Controller <u>Vendor services</u>

AND <u>NEVADAePro</u> in order to receive reimbursement payments.




RESEARCH GOALS AND PRIORITIES

We are interested in research with the following characteristics:

- Provides insight into the trends and forces that are shaping policy issues such as diversifying Nevada's workforce, increasing the talent pipeline, and improving educational outcomes for Nevada's students.
- Explores less trodden vectors of research, either with data sets that haven't been explored as thoroughly such as Adult Education or Workforce Development Programs, or new ways of looking at more popular data sets.
- Meta-research that examines the usefulness and efficacy of NPWR itself.
- Research that requires some unique aspect of NPWR to complete.
- Evaluation of the successes or failures of current programs and policies.
- Policy recommendations that would lead to better outcomes for Nevada's workforce development and education.


